

CCPA Privacy Notice

Why?	<p>The California Consumer Privacy Act of 2018 (CCPA) gives California residents the right to know what Personal Information HELIX RE collects about them, including whether it is being sold or disclosed to third-parties, and the right to prevent HELIX RE from selling that information. The CCPA also prevents companies from retaliating against consumers for exercising these rights – companies must continue to give consumers who exercise the right to refuse sale of their Personal Information access to equal products for equal prices.</p> <p>All companies need to collect and share consumers’ Personal Information for everyday business purposes, marketing, and maintenance of the safety, security, and integrity of their websites and other assets, among other reasons. This notice provides the information required under the CCPA and applies to both HELIX RE’s online and offline activities. What?	<p>The types of Personal Information we collect, disclose, and/or sell depend on your relationship with HELIX RE. If the nature of your relationship with HELIX RE changes, an additional data privacy notice may apply and will be provided to you.</p> <p>“Personal Information,” as used in this Notice, means any information that identifies, relates to, describes, or is capable of being associated with you or your household, whether directly or indirectly. Categories of Personal Information included in this definition are listed in the below chart.</p>

Sale or Disclosure of Your Personal Information	<p>We do not sell or disclose your personal information to other third-parties.</p>

Your Rights

You have the following rights with respect to your personal information:

- The right to a notice about our collection of information about you. This Notice is intended to satisfy this requirement.
- The right to request access to the personal information, including the specific pieces of information, that HELIX RE has about you, as well as the right to request rectification of any data that is inaccurate or incomplete.
- The right to request that we delete the personal information we have about you. We may not be required to delete information under particular circumstances
- The right to be free from retaliation for exercising your other rights. We may, however, offer you incentives in return for your data. When you exercise your rights, you may lose access to these incentives, which can include discounts, coupons, or additional services.
